General Instructions for Candidates Reporting for Admission (WBJEE-2026/Round-3)

All candidates allotted to Cooch Behar Government Engineering College (CGEC) through WBJEE-2026 Round-3 Counselling are hereby instructed to carefully follow all admission-related notices available under the “Admission-2026” section of the College Website (https://cgec.org.in/6_adm_2026.php). Candidates must complete the following requirements **before reporting to the Admission Office**.

Candidates are required to bring the following documents:

1. **One copy of the Round-1 Reporting data** (if applicable).
2. **One copy of the Round-2 Reporting data** (if applicable).
3. **One copy of the Round-3 Seat Allotment Letter**.
4. **Candidates who reported at another institution during Round 1 or Round 2** shall undergo **complete document verification**, similar to newly allotted candidates.
5. **Three sets (self-attested photocopies) of all required admission documents**, as specified in the notice titled “Documents Required for Admission” under the Admission-2026 section of the College Website (<https://cgec.org.in/Admission2026/Notice-Web-Documents-Required-for-Admission.pdf>).
6. **Three copies of the duly filled and signed Anti-Ragging Undertaking**. Candidates must complete the **Online Anti-Ragging Undertaking** by following the instructions provided in the relevant notice available under the Admission-2026 section of the College Website (<https://cgec.org.in/Admission2026/Notice-WEB-ANTI-RAGGING-UNDERTAKING.pdf>). Bring **three printed copies** of the duly completed and signed undertaking at the time of admission.
7. **Two photocopies and one original Medical Certificate** in the prescribed format available under the Admission-2026 section of the College Website (https://cgec.org.in/Admission2026/Medical_Form.pdf).
8. Candidates should be prepared to **pay the admission fees through SBI Collect only (Cash and Cheque payments are not accepted)** after the successful completion of document verification and reporting at the Admission Office. **Do not pay the admission fees before reporting**, unless specifically instructed by the Admission Office. Detailed payment instructions are available in the "Admission Fees Payment through SBI Collect" notice under the Admission-2026 section of the College Website (<https://cgec.org.in/Admission2026/Notice-Web-Payment-for-Admission-SBI-Collect-Pay.pdf>).

Important Instructions

- The entire admission process will be conducted by maintaining a **proper waiting queue**.
- As a large number of admissions are expected during **Round-3 Counselling**, candidates may have to wait for a considerable period before their turn.
- All candidates are requested to report with sufficient time and make appropriate travel arrangements.
- **Requests for priority, out-of-turn processing, or breaking the waiting queue on the grounds of return train/bus tickets or any personal convenience will not be entertained under any circumstances.**
